SCDCP, IS - C.

LA 3932-S ORALLY ADVISED THAT DISTRICT BOARD, SCDCP, HELD EMERGENCY MEETING AFTERNOON OF NOVEMBER 23 INSTANT, TO ASSESS IMPLICATIONS OF ASSASSINATION AND ESTABLISH TEMPORARY PARTY LINE FOR MEMBERS OF SCDCP. ENTIRE DISTRICT BOARD AGREED THAT NO EFFORT AT THIS TIME SHOULD BE MADE TO DEFEND ALLEGED ASSASSIN LEE H. OSWALD, OR "SCREAM FRAME-UP." DISTRICT BOARD ALSO CONCLUDED THAT CP SHOULD EXPECT INCREASED MC CARRAN ACT AND ULTRA-RIGHT ACTIVITIES. BUT THAT NO IMMEDIATE DANGER EXISTED FOR PICKUP BY FEDERAL AUTHORITIES OF CP MEMBERS.
